# Organizational Case Report Spring 2011-Fall 2021

This report was publicly released on March 11, 2022 by the Chair and Executive Committee of the University Judiciary Committee (UJC) pursuant to Article IX Section A (3) of the UJC By-Laws. This report presents information on UJC cases against Student Organizations adjudicated from the Spring 2011 semester to the Fall 2021 semester.<sup>1</sup>

The UJC By-Laws were amended by a vote of the Committee on January 30, 2022 to permit the release of finalized organizational case information including but not limited to "the date of adjudication; the Accused or Sanctioned Organization's name and type; relevant incident information; standards charged, verdicts, and pleas; any finalized sanctions, organizational restrictions, sanctions held in abeyance and their terms," *Supra.* (3)(a). The Chair and Executive Committee may limit or restrict release of information at their discretion, *Id*, and the Committee may not release otherwise confidential material relating to a UJC or Honor case against a student or another student group, nor personally identifiable information (PII) of any involved students or witnesses without a written waiver of their right to confidentiality for that purpose, *Supra* (3)(b). This officially released information is public and may be reproduced or published by any person, organization, or administrative office of the University, *Supra* (3)(e). All other information regarding these matters remains governed by the normal confidentiality provisions of the UJC By-Laws in Article IX Section A (1).

As this release is the first of its kind issued by the UJC -it encompasses organizational cases from the past ten years (Spring 2011 to Fall 2021) pursuant to the UJC records retention policies in Article VI Section D of the By-Laws. Beginning with the cases adjudicated in the Spring 2022 semester, organizational case information will be released once per semester or as otherwise deemed prudent by the Chair and Executive Committee.

The sanction and incident information sections listed for each case are abridged summaries and do not indicate the full text and scope of each sanction and incident.

These data do not include organizational cases which have been accepted but have not yet been adjudicated, or which have been adjudicated in the Spring 2022 semester or later. As of March 16, 2022 the UJC has adjudicated one (1) additional organizational case with another six (6) organizational cases pending on the docket.

## Student Organizational Contracts at UVa

The UJC has jurisdiction over alleged violations of the University Standards of Conduct by student organizations affiliated with the University. The Standards of Conduct and the UJC's jurisdiction are included within the terms of an organization's contract with the University. The two contract types seen herein are:

- 1. Fraternal Organization Agreements (FOAs) apply to most social Greek letter organizations, with oversight subdivided into four councils that work closely with Fraternity and Sorority Life (FSL—a unit of the Office of the Dean of Students [ODOS]): the Inter-Fraternity Council (IFC), the Inter-Sorority Council (ISC), the National Pan Hellenic Council (NPHC), and the Multicultural Greek Council (MGC)<sup>2</sup>.
- 2. **Contracted Independent Organizations (CIOs)** are clubs in relationship with the University which have access to Student Activities Fund (SAF) disbursements as administered by Student Council, as well as access to event space on Grounds. CIOs are supported by Student Engagement, a unit of ODOS.

## About the UJC

In instances where an accused party is found guilty of or pleads guilty to violating one or more of the Standards of Conduct, the elected student judges of the trial panel may assign no sanction, one sanction, or multiple sanctions. Sanctions are determined on a case-by-case basis, and the trial panel takes into account aggravating and mitigating factors. The UJC's mission is to maintain and promote a community of safety, respect, and freedom.

Please note, Sanctions listed as "in abeyance" are conditionally held sanctions that serve as a strong recommendation to a future UJC Trial Panel in the instance of future misconduct as specified.

The UJC is an entirely student-run organization made up of more than 110 students representing every one of the 13 schools of the University. The Committee is deeply grateful for the hard work of the many support officers and judges who have made this endeavor possible over the past many years and continue to do so.

These bodies' jurisdictions, processes, and outcomes are independent to that of the UJC and the UJC's jurisdiction over the University Standards of Conduct (*cf.* UJC Bylaws Article IX Section B [1]). The UJC appreciates the hard work and dedication of the IFCJC and ISCJB student members for the benefit of Greek life at the University and the larger community.


## Hazing

University policy STU-005 (Prohibition on Hazing) is an important component of intra-University investigations of hazing. Reports of hazing or retaliation may be referred directly to the UJC, ODOS, or Just Report It. If you are experiencing an emergency or believe that someone is in immediate danger, call 911.

#### COVID-19

University policy SEC-045 (COVID-19 Health & Safety Requirements – Vaccination, Testing, Face Masks, Events and Gatherings, and Visitors) has been a large component of the UJC's caseload since the Fall 2020 semester in light of the COVID-19 pandemic. The precise limits provided in this policy have changed numerous times since its inception. The UJC holds parties accountable to the text of the policy at the time of an incident.

#### The University Standards of Conduct

- 1. Physical assault of any person on University-owned or leased property, at any University sanctioned function, at the permanent or temporary local residence of a University student, faculty member, employee, visitor, or in the City of Charlottesville or Albemarle County, or Prohibited Conduct, as defined in the University of Virginia Policy on Sexual and Gender-Based Harassment and Other Forms of Interpersonal Violence.
- Conduct which intentionally or recklessly threatens the health or safety of any person on University-owned or leased property, at a University sanctioned function, at the permanent or temporary local residence of a University student, faculty member, employee or visitor, or in the city of Charlottesville or Albemarle County.
- 3. Unauthorized entry into or occupation of University facilities which are locked, closed to student activities or otherwise restricted as to use.
- 4. Intentional disruption or obstruction of teaching, research, administration, disciplinary procedures, other University activities, or activities authorized to take place on University property.
- 5. Unlawfully blocking or impeding normal pedestrian or vehicular traffic on or adjacent to University property.
- 6. Violation of University policies or regulations referenced in The Record, including policies concerning residence and the use of University facilities.<sup>3</sup>
- 7. Alteration, fabrication, or misuse of, or obtaining unauthorized access to University identification cards, other documents, or computer files or systems.
- 8. Disorderly conduct on University-owned or leased property or at a University-sanctioned function. Disorderly conduct is defined to include but is not limited to acts that breach the peace, are lewd, indecent, or obscene, and that are not Constitutionally protected speech.
- 9. Substantial damage to University-owned or leased property or to any property in the city of Charlottesville or Albemarle County or to property of a University student, employee, faculty member, or visitor, occurring on University-owned or leased property or at the permanent or temporary local residence of any student, faculty member, employee or visitor.
- 10. Any violation of Federal, State, or local law, if such directly affects the University's pursuit of its proper educational purposes and only to the extent such violations are not covered by other Standards of Conduct and only where a specific provision of a statute or ordinance is charged in the complaint.
- 11. Intentional, reckless, or negligent conduct which obstructs the operations of the Honor or Judiciary Committee, or conduct that violates their rules of confidentiality.
- 12. Failure to comply with directions of University officials acting under provisions 1-11 set above. This shall include failure to give identity in situations concerning alleged violations of sections 1-11.

#### Case Information (S11-F21)

Case 1: Pi Kappa Phi

Semester Filed: Spring 2021 Date Adjudicated: 09.08.2021

Standard(s): 2, 6 Case Summary:

The Beta Upsilon Chapter of the Pi Kappa Phi Fraternity (FOA, IFC Fraternity), pleaded guilty to violating four counts under Standards of Conduct 2 and 6 for holding two events at the Chapter's House in violation of SEC-045, not abiding policies concerning facial coverings, physical distance, and number of individuals (Then limited to 75 outdoors, 25 indoors). This was Pi Kappa Phi's second UJC case originating in Spring 2021. This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Termination in abeyance for further SEC-045 noncompliance; 4 week FOA Suspension (through 10.08.21); FOA probation through Spring 2022, Social probation through Fall 2021; Bylaws modification and creation of a Standards Committee; Monthly meetings with Alumniadvisors and FSL through 10.08.21.

## Case 2: St. Anthony Hall

Semester Filed: Spring 2021 Date Adjudicated: 09.02.2021

Standard(s):2,6 Case Summary:

St. Anthony Hall (The Upsilon chapter of the Fraternity of Delta Psi - FOA, IFC Fraternity) pleaded guilty to violations of Standards of Conduct 2 and 6 for holding an event at the Chapter's House in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to seventy-five outdoors). This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Suspension in Abeyance for further SEC-045 noncompliance; Bylaws modifications and presentation to membership; Reflective Essays by Executive Board Members; Monthly meetings with Alumni Advisors for one year (through 03.21.22); Community Service Project.

#### Case 3: Zeta Psi

Semester Filed: Spring 2021 Date Adjudicated: 05.05.2021

Standard(s): 6
Case Summary:

The Beta Chapter of the Zeta Psi Fraternity (FOA, IFC Fraternity) pleaded guilty to violating Standard of Conduct 6 for holding an event at the Chapter's House in violation of SEC -045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to six). This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Suspension in Abeyance for further SEC-045 noncompliance (through 05.05.22); CSC Covid Module (Executive Board); Community Service (2 week Volunteer Drive for COVID-19 relief); Action Plan Development and Presentation to membership, Notification of Nationals, Guest List Requirement (through 11.21); Reflective Essays by Executive Board Members.

#### Case 4: Theta Chi

Semester Filed: Spring 2021 Date Adjudicated: 05.04.2021

Standard(s): 2, 6, 9

Case Summary:

The Xi Chapter of the Theta Chi Fraternity (FOA, IFC Fraternity) pleaded guilty to violations of Standard of Conduct 2, 6, and 9 for hosting an off-grounds event in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to six indoor and twenty-five outdoors) in violation of Standards 2, and 6. At this gathering, substantial property damages were rendered by Theta Chi to a local business in violation of Standard 9<sup>4</sup>. This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Social Suspension of one year (through 05.04.22); Executive Board Honor pledge of compliance with the terms of the Suspension; Community service (Project); Apology Letter to the local business which suffered damage.

#### Case 5: Sigma Chi

Semester Filed: Spring 2021 Date Adjudicated: 04.20.2021

Standard(s): 2, 6 Case Summary:

The Virginia Psi Chapter of the Sigma Chi Fraternity (FOA, IFC Fraternity) pleaded guilty to violating two counts of Standard of Conduct 2, and three counts of violating Standard of Conduct 6 for three incidents at and around the Chapter's house in violation of SEC-045's enhanced restrictions and the Governor's Curfew Order not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to six). This was Sigma Chi's second case before the UJC within a six month period. This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Suspension of one semester (until the end of Spring 2021 school year); Social probation through the end of the Fall 2021 semester; Additional FOA Suspension of one year held in abeyance (for violation of any Standard of Conduct during the 2021-22 school year); Community Service (project); Notification to Nationals and Alumni Advisors; Codification of Bylaws regarding event policies.

## Case 6: Pi Kappa Alpha

Semester Filed: Spring 2021 Date Adjudicated: 04.15.2021

Standard(s): 2, 6 Case Summary:

The Alpha Chapter of the Pi Kappa Alpha Fraternity (FOA, IFC Fraternity) pleaded guilty to violations of Standard of Conduct 2 and 6 for hosting an off-grounds recruiting event in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to six indoors) in violation of Standards 2, and 6. This was Pi Kappa Alpha's second case before the UJC in a 3 month period. This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Suspension of three years in abeyance (for further violations of standards 2 or 6 by any brother); Notification to Nationals; codification of rules; Chapter completion of four educational essays; Creation of action plan; Executive Committee attendance to a leadership workshop & writing of a memo following; CORE presentation.

#### Case 7: Kappa Kappa Gamma

Semester Filed: Spring 2021 Date Adjudicated: 04.14.2021

Standard(s): 2, 6 Case Summary:

The Epsilon Sigma Chapter of the Kappa Kappa Gamma Sorority (FOA, ISC Sorority) pleaded guilty to violations of Standard of Conduct 2 and 6 for an off grounds "Bid Day" event in violation of the SEC-045 gathering limits (then limited to six). This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Suspension in Abeyance for further SEC-045 noncompliance; Community Service; Reflective essay for Executive Board members.

#### Case 8: Pi Kappa Phi

Semester Filed: Spring 2021 Date Adjudicated: 04.13.2021

Standard(s): 2,6

Case Summary:

The Beta Upsilon Chapter of the Pi Kappa Phi Fraternity (FOA, IFC Fraternity) pleaded guilty to violations of Standard of Conduct 6 for holding an event at the Chapter's House in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to six). This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Suspension in abeyance (for further SEC-045 noncompliance); Executive and Standards Board: Completion of the CSC COVID-19 Education Module, meeting with member of UVa Student Health COVID-19 task force; reflective essays; codification and posting of bylaws regarding guests and COVID-19 policies. *Please note the suspension in abeyance was triggered and is superseded by the sanctions in Case 1 of this report.* 

## Case 9: Kappa Alpha Theta

Semester Filed: Spring 2021 Date Adjudicated: 04.12.2021

Standard(s): 6 (charged but found not guilty of Standard 2)

Case Summary:

The Delta Chi Chapter of the Kappa Alpha Theta Fraternity<sup>5</sup> (FOA, ISC Sorority) was charged with violating Standard of Conduct 2, and 6 for holding a "Bid Day" event at the Chapter's House in violation of the SEC-045 gathering limits (then limited to six). Kappa Alpha Theta pleaded guilty to Standard 6, and was found not guilty of violating Standard 2 by the Trial Panel.

The Committee issued the following sanctions: Admonition; 30 day Social Probation held in abeyance; Community Service (Supply Drive); Executive Board completion of an apology letter to Charlottesville Community.

#### Case 10: Kappa Sigma

Case Number: U-S21-11 Semester Filed: Spring 2021 Date Adjudicated: 04.09.2021

Standard(s): 2,6 Case Summary:

The Zeta Chapter of the Kappa Sigma Fraternity (FOA, IFC Fraternity) pleaded guilty to violations of Standard of Conduct 2 and 6 for hosting an off-grounds recruiting event in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to six). This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Suspension in abeyance (for further SEC-045 noncompliance); Notification of Nationals and Advisors; appointment of a COVID-19 Compliance Officer; creation of a Standards Board; Executive Board presentation to membership about COVID-19 transmission and policies.

## Case 11: Virginia Belles

Semester Filed: Spring 2021 Date Adjudicated: 03.25.2021

Standard(s): 2, 6 Case Summary:

The a cappella group The Virginia Belles (CIO) pleaded guilty to violations of Standard of Conduct 2 and 6 for hosting an off-grounds event in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to six) in violation of Standards 2, and 6. This case was filed by a student.

The Committee issued the following sanctions: Admonition; CIO Suspension in abeyance (for further SEC-045 noncompliance); appointment of a chapter COVID Manager; codification of COVID regulations.

#### Case 12: Chi Phi

Semester Filed: Spring 2021

Date Adjudicated: 03.22.2021

Standard(s): 6 (charged by found & not guilty of Standard 2)

Case Summary:

The Alpha Chapter of the Chi Phi Fraternity (FOA, IFC Fraternity) was charged with violations of Standard of Conduct 2, and 6 for holding an event at the Chapter's House in violation of the SEC-045 gathering limits (then limited to six) after having been warned previously by University Police. Chi Phi pleaded guilty to violating Standard 6, and was found not guilty of violating Standard 2 by the Trial Panel.

The Committee issued the following sanctions: Admonition; Posting of Rules & Expectations; Essay by chapter to alumni & Nationals.

## Case 13: Pi Kappa Alpha

Semester Filed: Fall 2020

Date Adjudicated: 01.27.2021

Standard(s): 2, 6 Case Summary:

The Alpha Chapter of the Pi Kappa Alpha Fraternity (FOA, IFC Fraternity) pleaded guilty to two counts of violating Standard of Conduct 2 and three counts of violating Standard of Conduct 6 for hosting two simultaneous events in the Chapter's House in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to ten) In addition, one of these events was in violation of STU-001 (Use of Alcoholic Beverages and Prohibition of Other Drugs) regarding underage drinking. This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; notification to nationals; codification of policy regarding COVID-19, guests, and Health and Safety Officerrole; meetings with a Dean and Chapter Advisor; posting of chapter rules; guest sign in sheets for Chapter's house; Two educational presentations to membership (independent of the requirements by FSL as outlined by the FOA).

#### Case 14: Phi Gamma Delta

Semester Filed: Fall 2020

Date Adjudicated: 01.26.2021

Standard(s):2,6

Case Summary:

The Omicron Chapter of the Phi Gamma Delta Fraternity (FOA, IFC Fraternity) pleaded guilty to violations of Standard of Conduct 2 and Standard of Conduct 6 for hosting an event in a Chapter's satellite house in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to ten) in violation of Standards 2, and 6. This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; M ember attendance to two COVID information sessions; codification of accountability rules regarding COVID-19; communication with FSL leadership organizations; Guest list; appointment of a COVID-19 officer; recruitment probation in abeyance for SEC-045.

#### Case 15: Phi Society

Semester Filed: Fall 2020

Date Adjudicated: 01.22.2021

Standard(s): 2, 6 Case Summary:

The Phi Society Fraternity (FOA, IFC Fraternity) pleaded guilty to violations of Standard of Conduct 2 and Standard of Conduct 6 for hosting an event in a Chapter's house in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to ten). This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Suspension in abeyance (for further SEC-045 noncompliance or failure to complete IFCJC or UJC sanctions); Meetings with Dean; compile and publish chapter policies, and codify accountability process; Community Service (PPE Donation Drive)

## Case 16: Sigma Alpha Epsilon:

Semester Filed: Fall 2020

Date Adjudicated: 01.20.2021

Standard(s): 2, 6 Case Summary:

The Virginia Omicron Chapter of the Sigma Alpha Epsilon Fraternity (FOA, IFC Fraternity) pleaded guilty to violations of Standard of Conduct 2 and Standard of Conduct 6 for hosting an event in a Chapter's house in violation of SEC-045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to ten). This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; FOA Suspension in abeyance (for further SEC-045 noncompliance); Guest limits and list requirements through 04.21; Codification and posting of COVID-19 in the Chapter's House; Executive Board: completion of reflective essay, meeting with Dean; Notification of Nationals; Notification of meaningful alumni; resource database creation; risk management meeting meetings submission to the UJC; two executive board educational presentations to membership on COVID-19 policy and risk management.

## Case 17: Sigma Alpha Mu

Semester Filed: Fall 2020

Date Adjudicated: 11.12.2020

Standard(s): 6
Case Summary:

The Beta Psi Chapter of the Sigma Alpha Mu Fratemity (FOA, IFC Fraternity) pleaded guilty to violating Standard of Conduct 6 for hosting an event in a Chapter's house in violation of SEC -045, not abiding Policies concerning facial coverings, physical distance, and number of individuals (then limited to five). This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; Community Service (PPE Donation Drive); FOA Suspension in abeyance (up to three years, for any Standard of Conduct 6 violation by any active brother); House Visitors Log (until 05.24.21); Apology Letter from the Chapter to the Greek Life Community and neighbors on Chancellor Street.

## Case 18: Sigma Chi

Semester Filed: Spring 2020 Date Adjudicated: 09.23.2020

Standard(s): 2 Case Summary:

The Virginia Psi Chapter of the Sigma Chi Fraternity (FOA, IFC Fraternity) pleaded guilty to violating Standard of Conduct 2 for an incident involving the egging of nonaffiliated persons and a vehicle near their Chapter's House. This case was filed by the Office of the Dean of Students (ODOS).

The Committee issued the following sanctions: Admonition; Chapter Apology letter; Executive Board create and deliver an educational presentation to membership about conflict deescalation and risk management.

#### Case 19: Trigon Engineering Society

Semester Filed: Spring 2017 Date Adjudicated: 04.13.2017

Standard(s):6
